Morningstar Low Carbon Designation™

This is assigned to portfolios that have low-carbon risk scores and low levels of fossil fuel exposure. The designation is an indicator that the companies held in a portfolio are in general alignment with the transition to a low-carbon economy.²



Science-Based Targets

We encourage the companies we invest in to adopt science-based targets to reduce GHG emissions. **58%** of companies held by the Fund as of 6/30/2025 had set or committed to science-based targets.³

Promoting Diversity

Gender and racial diversity on corporate boards helps mitigate governance risks and promote a more equitable, inclusive culture. The Fund does not invest in any company lacking gender diversity and leverages proxy voting to help drive improvement. In 2024, the Fund opposed **47%** of board director elections due to insufficient diversity.⁴

Exclusionary Standards

When you invest in the Domini Funds, you avoid investing in certain business activities that we believe are fundamentally misaligned with our goals of universal human dignity and ecological sustainability, including:

- Nuclear Power
- Fossil Fuels

3. 28 of 48 companies held by the Fund as of 6/30/2025 have set or committed to science-based targets, according to the Science-Based Targets initiative (SBTi), including 24 that have had their targets validated by SBTi and 4 that have made commitments to develop targets and submit them for validation within 24 months.

4. During 2024, the Fund voted to oppose 158 out of 292 director election proposals, including 136 opposed due to insufficient diversity. In certain markets, where data is available, both racial and gender diversity is considered when evaluating board diversity.
